Age Requirements: High School and Up

Captain's Meeting: Tuesday, Jan. 10th @7:00pm in the Family Life Center at WBC.

Games are played Saturdays, beginning January 21th, and the times will depend on the number of teams registered.

Registration Fee: \$400 per team. Fee includes team shirts and the champion team will also receive championship shirts.

The season will include 7 games, and conclude with a single game elimination tournament. Games will be played 7 on 7.

- A team representative must be present at the captains meeting; No representative = No team.
- All teams must be registered and have team fee paid before first game. No new teams will be added after captains meeting has taken place.
- Each team must pay before they are eligible to play
- There will be a forfeit cost of \$50 if your team doesn't give 24-hour notice of cancellation.
